Summary prepared by the Office of the United Nations High Commissioner for Human Rights in accordance with paragraph 15 (c) of the annex to Human Rights Council resolution 5/1 and paragraph 5 of the annex to Council resolution 16/21

Venezuela (Bolivarian Republic of)*

The present report is a summary of 519 stakeholders' submissions¹ to the universal periodic review. It follows the general guidelines adopted by the Human Rights Council in its decision 17/119. It does not contain any opinions, views or suggestions on the part of the Office of the United Nations High Commissioner for Human Rights (OHCHR), nor any judgement or determination in relation to specific claims. The information included herein has been systematically referenced in endnotes and, to the extent possible, the original texts have not been altered. As provided for in Human Rights Council resolution 16/21, where appropriate, a separate section is provided for contributions by the national human rights institution of the State under review that is accredited in full compliance with the Paris Principles. The full texts of all submissions received are available on the OHCHR website. The report has been prepared taking into consideration the periodicity of the review and developments during that period.

I. Information provided by the national human rights institution of the State under review accredited in full compliance with the Paris Principles²

1. The Ombudsman's Office of the Bolivarian Republic of Venezuela (DdPV) indicated that measures should be put in place to implement the Convention on the Rights of Persons with Disabilities and the Optional Protocol thereto, the Bolivarian Republic of Venezuela having recently acceded to both instruments.³

2. The Ombudsman's Office drew attention to the establishment of the National Human Rights Council, the 2015-2019 Human Rights Plan, and the adoption of legislation to protect a range of population groups.⁴

3. The Office welcomed the fact that the Bolivarian Republic of Venezuela had submitted its reports and had sent high-level delegations to present them at all meetings with treaty bodies held during the period 2012-2015.⁵

4. The Ombudsman's Office stated that NGOs, community organizations and activists were consulted during the preparations for the universal periodic review process and that the Office had undertaken an exhaustive follow-up exercise to monitor implementation of the 2011 recommendations.⁶

5. With regard to the first-cycle recommendations, it indicated that although the participation of women in decentralized bodies has increased, gender parity has not yet been reached.⁷

6. With regard to the protection of vulnerable groups, it highlighted policies and bodies created to protect the rights of children, women, older persons, homeless persons, persons living with HIV/AIDS, lesbian, gay, bisexual, transgender and intersex (LGBTI) persons, and indigenous peoples.⁸

7. The Office welcomed the fact that a ministry has been established and a prison code has been adopted⁹ in follow-up to the recommendations on conditions in prisons and recommended strengthening guarantees of due process.¹⁰

8. The Office acknowledged the existence of a policy for combating crime and violence but indicated that the policy needs to be reviewed and streamlined.¹¹ With regard to the recommendation to pass a law ending the illegal circulation of firearms, it provided information on the creation of the Presidential Commission on Arms, Munitions and Disarmament Control, the Voluntary Disarmament Plan and the opening of arms collection centres throughout the country.¹²

9. With regard to the recommendations concerning the legal and judicial system,¹³ it welcomed the reform of the Criminal Code but highlighted the punitive culture that makes bail during trial the exception rather than the rule.¹⁴

10. With regard to grass-roots democracy and socioeconomic development, the Office stated that the Bolivarian Republic of Venezuela has strengthened its social policies on education, health and culture and called for the creation of mechanisms to ensure the continued application of such policies.¹⁵

11. The Office highlighted the success of the Great Venezuelan Housing Mission.¹⁶

12. It stated that 96 per cent of the population has access to drinking water and 84 per cent enjoys improved sanitation services.¹⁷

13. The Office noted that 85 per cent of asylum applications are rejected and refugee protection obligations are not being met.¹⁸

II. Information provided by other stakeholders

A. Background and framework

1. Scope of international obligations¹⁹

14. CDH-UCAB noted that, despite having accepted related recommendations, the Bolivarian Republic of Venezuela still has not ratified certain human rights instruments.²⁰ OVP reported that the Bolivarian Republic of Venezuela has not yet ratified the International Convention for the Protection of All Persons from Enforced Disappearance and the Optional Protocol to the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment, among other instruments.²¹

15. PROVEA noted that the Bolivarian Republic of Venezuela has not reversed its decision to withdraw from the American Convention on Human Rights.²² JS20 asserted that the Bolivarian Republic of Venezuela had flouted both merits reports and precautionary measures issued by the Inter-American Commission of Human Rights, and sentences and provisional measures issued by the Inter-American Court of Human Rights (IAHR Court/Corte-IDH). JS20 recommended that the Bolivarian Republic of Venezuela comply with the decisions of international organizations.²³

2. Constitutional and legislative framework

16. HRW stated that the Bolivarian Republic of Venezuela should complete the alignment of its national legislation with the Rome Statute of the International Criminal Court.²⁴

3. Institutional and human rights infrastructure and policy measures

17. PROVEA noted that the Bolivarian Republic of Venezuela has not complied with the recommendation to implement a comprehensive approach to the follow-up of the universal periodic review,²⁵ in that it has failed to establish a mechanism for following up policies and measures adopted to implement the recommendations.²⁶

18. ROA drew attention to the creation of institutional bodies tasked with combating racial discrimination and strengthening Afro-descendant communities.²⁷ RAV pointed out that these bodies have failed to develop policies for restoring the rights of such communities.²⁸

19. JS29 called for a special unit to be established within the Ombudsman's Office to defend the human rights of LGBTI persons.²⁹ EJERCITOEMANCIPADOR recommended the creation of a special prosecutor to try cases of discrimination and hate against LGBTI people.³⁰

20. With regard to a noted recommendation, CDH-UCAB welcomed the adoption of a National Human Rights Plan of Action. It claimed, however, that the drafting process was not based on a consensual construction of a prior diagnosis.³¹ PROVEA stated that some social and political groups who are critical of the Government were excluded from the consultation process.³² AI noted that the approved 2016-2019 National Human Rights Plan includes proposals to reform the judiciary, the prison system and the security forces and to strengthen the Ombudsperson's Office, as well as proposals to mainstream human rights

education.³³ JS13 recommended that the Plan should facilitate compliance with the obligations and recommendations of international human rights bodies.³⁴

21. JS10 underscored the absence of a national plan for the protection of the rights of children.³⁵ FRPOIAMA recommended the creation of a specialized policing unit for the prevention of child abuse.³⁶

22. Four organizations commended the cooperation and solidarity programmes agreed with other countries in the areas of education, health and energy.³⁷

B. Cooperation with human rights mechanism

23. SINERGIA called for the recommendations related to cooperation with regional and international human rights bodies that were accepted in the 2011 universal periodic review to be implemented.³⁸

1. Cooperation with treaty bodies

24. FPV stated that the Bolivarian Republic of Venezuela has decided not to comply with resolutions, opinions and measures adopted by various regional and international human rights bodies.³⁹

2. Cooperation with special procedures

25. SINERGIA called for the recommendations made in the previous universal periodic review to be implemented by issuing standing invitations to special rapporteurs and accepting their visit requests.⁴⁰

26. AI recommended agreeing to visits by, inter alia, the Special Rapporteur on Freedom of Association and Assembly.⁴¹

27. JS15 recommended issuing invitations to the Special Rapporteur on torture and other cruel, inhuman or degrading treatment or punishment, the Special Rapporteur on extrajudicial, summary or arbitrary executions, and the Special Rapporteur on violence against women, its causes and consequences.⁴² IPYS recommended agreeing to visits from the Special Rapporteur on the promotion and protection of the right to freedom of opinion and expression, the Special Rapporteur on the right to privacy, and the Special Rapporteur on the situation of human rights defenders.⁴³ LabPaz recommended authorizing a visit by the Special Rapporteur on the rights of indigenous peoples.⁴⁴

28. JS20 stated that the Bolivarian Republic of Venezuela has failed to comply with the recommendations of the Working Group on Arbitrary Detention.⁴⁵

C. Implementation of international human rights obligations, taking into account applicable international humanitarian law

1 Equality and non-discrimination

29. JS24 welcomed the acceptance of a recommendation on racial discrimination,⁴⁶ but noted the persistent discrimination directed at Afro-descendant and indigenous communities.⁴⁷

30. JS24 acknowledged efforts to implement recommendations to promote the rights of women.⁴⁸ GCC acknowledged in particular the public policies designed to eliminate obstacles linked to sociocultural stereotypes.⁴⁹ C.H.FREYA stated that sexism and stereotypes are prevalent.⁵⁰ OMIAW indicated that there are no specific guarantees of

protection and support for indigenous women.⁵¹ JS6 noted that the “Mamá Rosa” Gender Equality and Equity Plan has a political and ideological bias and that gender mainstreaming criteria are not being applied.⁵² JS24 stated that gender equality plans have been ineffective.⁵³

31. With regard to the recommendations concerning the participation of women in political life,⁵⁴ GCC noted that, although women play key roles in local management bodies, they have limited access to positions of power and decision-making.⁵⁵ FDIIM recommended strengthening efforts to achieve parity in legislation and in the exercise of political power.⁵⁶

32. JS3 asserted that the Act on the protection of equal rights for people living with HIV/AIDS marks a step forward, but that it does not meet all the criteria recommended by the Committee on Economic, Social and Cultural Rights and the Committee on the Rights of the Child with regard to non-discrimination.⁵⁷

33. According to JS29, the Bolivarian Republic of Venezuela has not taken measures to ensure the social and legal inclusion of LGBTI persons, as was recommended.⁵⁸ ROMPELANOR recommended adopting legislation to combat discrimination on grounds of sexual orientation and provide for equal marriage.⁵⁹ VeneDiver reported discrimination against LGBTI persons in the workplace.⁶⁰

34. JS17 indicated that the Bolivarian Republic of Venezuela has no strategies for addressing population ageing, that there are not enough care homes, and that those that do exist do not guarantee an appropriate environment.⁶¹

2. Right to life, liberty and security of the person

35. JS11 highlighted that in 2015 the murder rate rose to 90 per 100,000 inhabitants.⁶² FRPOIAMA reported that the number of violent deaths among children and adolescents has not declined, with 912 killed in 2014.⁶³ JS6 pointed out that there is no system for the collection of disaggregated statistical data.⁶⁴

36. JS27 warned of the growing militarization of society and civil security.⁶⁵ JS35 recommended the adoption of a civil security policy that does not incorporate military methods and is not implemented or overseen by military bodies.⁶⁶ JS12 reported that parastatal civilian groups have been involved in attacks on civilians and maintaining public order.⁶⁷

37. JS15 documented 1,018 cases of alleged extrajudicial killings in 2014 and 1,396 in 2015, noting that police units were implicated in the majority of them.⁶⁸ JS35 reported that the number of extrajudicial killings and arbitrary arrests rose sharply in 2015 following implementation of the security plan known as the People’s Liberation and Protection Operation.⁶⁹

38. Referring to a noted recommendation to fight against the misuse of power by the security forces,⁷⁰ HRW indicated that security forces have responded to protests with brutal force, severely abused detainees, and that there are credible allegations that they have carried out extrajudicial killings.⁷¹ CIVICUS stated that the January 2014 protests were marked by excessive and lethal force and persecution of opposition party members and human rights defenders.⁷² On the other hand, JS21 indicated that acts of violence by opposition groups were portrayed as peaceful protests by the private media.⁷³ CVG recommended that efforts to bring the perpetrators of acts of violence committed during such protests to justice should be intensified.⁷⁴

39. In 2014 and 2015, FPV registered more than 100 cases of torture and cruel and inhuman punishment of detainees, including the use of electric shocks and sexual assaults.⁷⁵ AI underscored the creation of a legal and institutional framework for preventing, reporting

and punishing torture and other ill-treatment, and recommended making a punishable offence the acts of public officials who instigate or consent to acts of torture by others.⁷⁶ FPV stated that the Ombudsman's Office has not followed up on complaints of torture committed against persons deprived of their liberty for political reasons.⁷⁷

40. With regard to the recommendations concerning prisons,⁷⁸ OVP noted the commitment to increase the number of prisons and to demolish the most overcrowded places of detention.⁷⁹ RENADDHH concluded that the efforts made to date had been insufficient.⁸⁰ UVAL maintained that persons deprived of their liberty continue to live in degrading conditions.⁸¹ AI recommended implementing the provisional measures issued by the IACHR and the IAHR Court in relation to the threat to the right to life and security of inmates.⁸²

41. With regard to the recommendations on violence against women,⁸³ JS11 indicated that no dedicated plans for eliminating such violence are in place.⁸⁴ JS41 noted the various programmes and institutions created to address violence against women but perceived a need to establish a coordinating body.⁸⁵ JS6 stated that the definition of the offence of femicide has not been amended to encompass State responsibility by act or omission.⁸⁶

42. With regard to the recommendations on human trafficking,⁸⁷ PAS and FDIM welcomed initiatives to prevent and punish such offences and recommended introducing incentives to encourage greater community participation.⁸⁸ OMIAW reported that in some areas trafficking and prostitution of indigenous girls, adolescents and women are controlled by non-State armed groups acting in partnership with Venezuelan soldiers and miners.⁸⁹

3. Administration of justice, including impunity and the rule of law

43. AI reported that impunity for violations of human rights is widespread and cited official statistics covering 2009-2012 that show that only 3 percent of formal complaints of human rights violations result in the suspects being charged. Since 2012, the Attorney General's Office has not provided up-to-date statistics.⁹⁰

44. JS23 drew attention to the serious, ongoing deterioration in the independence of the justice system.⁹¹ Acceso referred to the decline in judicial independence and recommended that the State amend the regulatory framework, enact a code of ethics, cease interfering in judicial appointments and the administration of judicial remedies, stop using appeals for interpretation and ex officio proceedings as a means to legitimize Government actions, and end the practice of legislating on the basis of court rulings.⁹²

45. Acceso recommended separating the 2013-2019 Strategic Plan for the Judiciary from the Government Plan, complying with the regulations on the appointment of judges and establishing a system of accountability.⁹³

46. FPV stated that more than 60 per cent of judges and more than 90 per cent of criminal judges do not have tenure.⁹⁴ PROVENE regretted the fact that non-tenured judges can be removed by the Judicial Commission, which is an administrative body.⁹⁵

47. FPV stated that the detention of judge María Lourdes Afuni had led to intimidation and resulted in the justice system being used as a political weapon.⁹⁶ AI recommended releasing prisoners of conscience Leopoldo Lopez and Rosmit Mantilla.⁹⁷

48. JS15 made reference to decisions of the Constitutional Chamber of the Supreme Court which declare a judgment of the Inter-American Court of Human Rights to be unenforceable because "it violates the sovereignty of the State" and call upon the Government to withdraw from the Convention.⁹⁸ JS12 reported that the Constitutional Chamber has also validated laws that fail to recognize the legitimacy of civil society⁹⁹ and has intervened in the internal elections of trade union organizations, political parties and national universities.¹⁰⁰

49. JS27 recommended restricting the jurisdiction of military courts to military offences only.¹⁰¹

50. CATEDRAGUAICAIPURO noted the conflict between special indigenous courts and ordinary courts.¹⁰² OTSOAAM underscored the urgency of implementing the bill on special indigenous courts following the public consultation process.¹⁰³

51. CODEHCIU drew attention to the limitations imposed on the work of defence lawyers, the abuse of power frequent among justice system officials and the telephone tapping and other activities carried out without a court order.¹⁰⁴

4. Right to privacy

52. JS37 considered legislation governing communications surveillance to fall short of international human rights standards.¹⁰⁵ It fails to prescribe tests of necessity and proportionality, and there is no provision requiring authorities to notify individuals or groups that they are, or have been, subject to surveillance.¹⁰⁶ JS37 reported a lack of public oversight mechanisms on authorisations for surveillance.¹⁰⁷

53. JS37 reported that intelligence agencies have conducted surveillance based on political considerations.¹⁰⁸ JS37 argued that the Executive exercises influence over the telecommunications sector, leaving private communications and personal information at risk of illegitimate political interference.¹⁰⁹

5. Freedom of religion or belief, expression, association and peaceful assembly, and right to participate in public and political life

54. DHI considered that in the Bolivarian Republic of Venezuela there is freedom of religion, belief, expression of ideas and thought, association, assembly and peaceful demonstration.¹¹⁰

55. A total of 29 organizations mentioned the adoption of the Act on Community and Alternative Media and the creation of around 1,200 Internet information centres called “Infocentros”, many of which are Government-sponsored and free of charge for users, for disadvantaged communities and population groups.¹¹¹

56. JS16 highlighted the lack of access to public information.¹¹² EPAC recommended adopting legislation and public policies to guarantee access to public information¹¹³ and JS40 recommended establishing an independent body to guarantee such access.¹¹⁴

57. JS16 asserted that the Act on Social Responsibility in Radio, Television and Electronic Media grants the National Telecommunications Commission too much discretion in sanctioning media organizations for their editorial line.¹¹⁵ HRW reported that the Government has abused its powers to regulate the media, has taken aggressive steps to reduce the availability of media outlets that engage in critical programming, and that fear of reprisals has made self-censorship a serious problem.¹¹⁶

58. IPYS asserted that fundamental guarantees for the exercise of freedom of expression and the right to freedom of opinion have been eroded, with an increase in attacks, censorship, arbitrary detentions, police surveillance, arbitrary interception of communications and abuse of power by State authorities.¹¹⁷ FPV stated that 77 people were still in prison for political reasons as of March 2016 and recommended their immediate release.¹¹⁸

59. JS25 recommended reviewing legislation guaranteeing the right to freedom of expression, establishing a regulatory mechanism to prevent the abuse of State-owned media for propaganda purposes, and developing a comprehensive media management policy.¹¹⁹

EPAC recommended guaranteeing media outlets unregulated access to paper and printing materials and depoliticizing the allocation of radio frequencies.¹²⁰

60. JS16 asserted that judges enjoy wide discretion in determining whether a given act constitutes an offence of contempt or denigration and that such charges have been brought against persons critical of the Government.¹²¹ EPAC recommended repealing the provisions on contempt, denigration and libel and preventing criminal charges from being brought as punishment for holding dissident opinions.¹²²

61. CIVICUS indicated that the Supreme Court rejected the ruling of the IAHR Court (2015) which ordered the Bolivarian Republic of Venezuela to reinstate the license of a broadcasting station closed in 2007.¹²³

62. CIVICUS recommended creating a legislative framework for the protection of human rights defenders.¹²⁴ AI stated that despite accepted recommendations,¹²⁵ the Bolivarian Republic of Venezuela had failed to guarantee that human rights defenders can carry out their work without fear of reprisals and recommended halting attacks and campaigns against them.¹²⁶ JS26 reported that numerous laws restrict independent NGOs.¹²⁷ CIVICUS stated that human rights defenders and civil society activists had been subjected to judicial harassment and extra-legal killings.¹²⁸ RSF-RWB reported on assaults committed against journalists from public and private media.¹²⁹ JS20 recommended carrying out investigations of the violence against human rights defenders.¹³⁰

63. Around 50 organizations asserted that high-level officials have used public media outlets to discredit and make arbitrary accusations against independent human rights defenders, journalists and media that have voiced criticism.¹³¹

64. IACHR made reference to the precautionary measures it had requested to protect the situation of human rights defenders, political dissidents and persons deprived of their liberty.¹³² FPV indicated that the Bolivarian Republic of Venezuela has not complied with precautionary measures ordered by the Commission.¹³³

65. A number of organizations reported on intimidation, harassment and, in some cases, surveillance of defenders, in particular after their participation in UN meetings and IACHR's hearings.¹³⁴

66. CIVICUS recommended bringing laws that deal with freedom of association into conformity with best practices prescribed by the United Nations Special Rapporteur on the rights to freedom of peaceful assembly and of association.¹³⁵

67. CVG recommended that the State ensure that exercise of the right to peaceful demonstration does not impede exercise of the rights of others.¹³⁶ EPAC asserted that the State's response to a series of protests in February 2014 was disproportionately repressive since around 82 per cent of the protests repressed had been peaceful.¹³⁷

68. OVCS stated that Decision No. 276-24/4/2014 of the Supreme Court established that it is obligatory to request a permit to exercise the right to peaceful demonstration and ordered the security forces to disperse any demonstration organized without such a permit.¹³⁸

69. JS15 stated that Resolution No. 008610 (2015) of the Ministry of People's Power for Defence, on controlling protests, provided fertile ground for the abuse of firearms, particularly in the absence of independent civilian oversight.¹³⁹ EPAC warned that the Resolution extended the scope for military officials to intervene and gives them discretion to use firearms to maintain public order.¹⁴⁰

70. SINERGIA recommended allowing access to international funding for human rights organizations.¹⁴¹

71. CJB recommended encouraging young people to participate more in the National Youth System.¹⁴²

72. RAV recommended guaranteeing the participation of Afro-descendants in electoral processes.¹⁴³

73. TCC noted an extensive participation of officials in campaign activities notwithstanding that the Election Act prohibits them from carrying out such activities in the exercise of public duties.¹⁴⁴

74. A total of 238 organizations welcomed the reinforcement of people's power and popular governance and recommended further extending the work that civil society organizations and movements perform in partnership with the various government entities at the local, regional, state and national levels.¹⁴⁵

75. On the other hand, SINERGIA indicated that the set of people's power laws, pursuant to which organized society is engaged in the exercise of public management duties, blurs the traditional boundaries of relationships between independent civil society and the State.¹⁴⁶ SINERGIA stated that the People's Power Finance Act excludes forms of association and participation not envisaged under the communal system.¹⁴⁷

6. Right to work and to just and favourable conditions of work

76. COB highlighted the adoption of the Labour and Workers Act.¹⁴⁸ MOVINOTINTO indicated that no data are available on unemployment rates.¹⁴⁹

77. JS20 expressed the view that there had been no will to comply with the recommendations of International Labour Organization (ILO) bodies.¹⁵⁰

78. PROVEA indicated that interference in trade union electoral processes, obstacles to the registration of trade unions critical of the Government, the obstruction of petitions and the refusal of trade union licenses for public sector workers were continuing problems. In addition, trade union officials continued to face dismissal, public denigration, police harassment and detention, and to be criminalized for exercising the right to demonstrate in public.¹⁵¹

7. Right to social security and to an adequate standard of living

79. FMB200-Anz stated that social investment remains a priority.¹⁵² JS28 noted that the commitment to respecting human rights is reflected in the policies and operation of the Social Missions.¹⁵³ JS41 underscored the progress made in implementing recommendations on poverty eradication.¹⁵⁴ According to JS11, recommendations linked to the rights to education, health, housing and food that are listed as having been implemented or being in the process of implementation have not in fact been fulfilled.¹⁵⁵

80. A total of 487 organizations called for the continuation of social investment policies and programmes focused on education, health, housing, economic activity, development and the environment, including the Barrio Adentro, Ribas, Sucre, Robinsón, Agrovenezuela, A toda Venezuela, En Amor Mayor, Hijos de Venezuela, Jóvenes de la Patria, Alimentación, Identidad, Madres del Barrio and Guacaipuro Missions, the Great Venezuelan Housing Mission, the Great Sucre Mission and the Great Cubanas Mission (Barrio Adentro Deportivo, Salud).¹⁵⁶

81. Referring to recommendations on housing,¹⁵⁷ IHRC-OU acknowledged the commitment to the Mission Vivienda Venezuela but reported that goals for housing development had largely gone unmet.¹⁵⁸ REDINQUILINOS recommended increasing the provision of decent housing.¹⁵⁹

82. Around 15 organizations expressed concern about the food and nutrition situation.¹⁶⁰ JS38 noted the lack of official data on child malnutrition.¹⁶¹ JS34 indicated that there is no objective mechanism for evaluating the Food Mission and recommended boosting food production.¹⁶²

83. DEFENSORESDDHH recommended continuing to implement food distribution plans.¹⁶³ AfOT noted that (on 16 June 2013) the Bolivarian Republic of Venezuela was recognized by the UN Food and Agriculture Organization for surpassing the first Millennium Development Goal of halving hunger.¹⁶⁴

84. A total of 102 organizations highlighted the benefits of engaging community stakeholders in the implementation of projects to ensure access to, and rational use of, drinking water and to promote environmental sanitation. The organizations recommended continuing efforts to strengthen people's power by means of the community councils, technical water committees and integrated community brigades; guaranteeing 100 per cent water supply coverage; developing municipal ordinances for the management and use of water; and providing training in the integrated and rational use of water resources.¹⁶⁵

8. Right to health

85. A total of 21 organizations reported that progress had been made in adopting health legislation to ensure compliance with constitutional provisions prescribing free, high-quality health services for all. A number of submissions reported an increase in health-sector investment and highlighted the implementation of public policies and social programmes such as the Barrio Adentro Mission (I, II and III) as models of integrated health-care management.¹⁶⁶

86. HRW reported that Venezuelans continue to experience a deterioration of their ability to access basic health services.¹⁶⁷ A number of organizations considered that the Government has not been able to provide the public health-care system with medicines and supplies formerly available.¹⁶⁸ JS38 underlined the extreme shortages of essential medicines, supplies and reagents.¹⁶⁹ JS9 stated that medical staff in charge of health centres are forced to take responsibility for the respective treatments as the authorities do not allow them to disclose the lack of medicines.¹⁷⁰

87. OMIAW highlighted the development of the first National Plan for the Protection of Sexual and Reproductive Rights for the period 2014-2019, which includes indigenous women but has not been allocated a budget.¹⁷¹ JS40 referred to challenges affecting the coverage of contraception and family planning programmes.¹⁷² JS38 recommended increasing access to sexual and reproductive health services.¹⁷³ JS5 recommended implementing a comprehensive sexual education programme as a means of eliminating violence against women.¹⁷⁴

88. JS6 indicated that the programme and plan for safe, wanted and happy motherhood are based on a populist, maternalist handout-oriented approach.¹⁷⁵ JS11 stated that there are no public policies to address teenage pregnancies.¹⁷⁶

89. FDIM and PAS indicated that maternal mortality rates in indigenous communities are high.¹⁷⁷ FDIM recommended developing plans to ensure a multicultural, multi-ethnic approach to the provision of prenatal care.¹⁷⁸ JS19 indicated that there has been a decline in attention to indigenous health.¹⁷⁹

90. VeneDiver indicated that LGBTI persons are subjected to psychological abuse in health centres.¹⁸⁰ UNAF stated that gynaecological services are not adapted to the needs of LGBTI persons.¹⁸¹

9. Right to education

91. A total of 40 organizations reported advances in the provision of free education at all levels (primary, secondary and university). They welcomed educational programmes such as the Mission Robinson “Yo sí puedo” (yes, I can) programme, the Ribas and Sucre missions, the Simoncito project, and computer literacy and online training initiatives, noting that these programmes have been recognized by the Organization of Ibero-American States for Education, Science and Culture and the United Nations Educational, Scientific and Cultural Organization (UNESCO). Some organizations recommended that access to high-quality public education should be improved and current education legislation should be maintained.¹⁸²

92. JS31 reported positive outcomes including a reduction in school dropout rates and the introduction of a school meals programme.¹⁸³ CEAAL recommended further improving access to free high-quality education, ensuring that teachers receive appropriate training, and safeguarding their rights.¹⁸⁴

93. IHRC-OU-Norman-Oklahoma stated that children in rural areas, indigenous and afro-descendant people, refugee children, and asylum seekers faced barriers in achieving adequate education.¹⁸⁵ CATEDRAGUAICAIPURO reported a shortage of indigenous teachers and a lack of funding for mother-tongue and bilingual textbooks.¹⁸⁶

94. VeneDiver referred to the harassment and degrading treatment that caused LGBTI persons to drop out of education.¹⁸⁷ UNAF indicated that teachers and educational authorities do not know how to address issues of sexual orientation, gender identity and gender expression.¹⁸⁸

95. JS1 reported that national autonomous universities have been discriminated against in the allocation of budgets, that student organizations at these universities have been stigmatized and that legitimate protests led by these organizations have been criminalized.¹⁸⁹

10. Cultural rights

96. ABDAPC drew attention to the cultural policies and increase in the cultural budget which have improved access to cultural goods and services.¹⁹⁰ CCCdelALBA recommended strengthening the Corazón Adentro Cultural Mission.¹⁹¹

97. APIVEN recommended adopting a multidimensional approach to the preservation of indigenous languages and promoting intercultural education.¹⁹²

11. Persons with disabilities

98. With regard to the recommendations on persons with disabilities,¹⁹³ ACIMIR highlighted the ratification of the Convention on the Rights of Persons with Disabilities by the Bolivarian Republic of Venezuela and the need both to guarantee non-discrimination and accessibility and to bring legislation in line with the Convention.¹⁹⁴ EVV highlighted the ratification of the Optional Protocol to the Convention on the Rights of Persons with Disabilities,¹⁹⁵ but expressed the view that the recommendations have not been fulfilled. It recommended that the recommendations should be maintained for the next reporting period and that civil society organizations should be involved in follow-up.¹⁹⁶

99. FLUZPARATODOS highlighted that raising public awareness of disability issues was a challenge.¹⁹⁷

100. EVV reported that the reforms to special education services had been implemented without consulting students or their parents or representatives.¹⁹⁸ ACIMIR called for

recommendations made by persons with disabilities to be brought to the notice of the relevant public policy bodies.¹⁹⁹

101. DID drew attention to various inclusive education programmes, and to the lack of up-to-date data on persons with disabilities and on the outcomes of Government programmes and missions.²⁰⁰

102. ASODACI recommended encouraging the formation of associations of persons with disabilities and the development of productive initiatives to guarantee their autonomy, independence and social inclusion.²⁰¹

12. Indigenous peoples

103. APIVEN, JS19, JS24 and JS33 noted that recommendations concerning the integration of indigenous peoples and respect for their rights had not been met.²⁰² JS19 stated that little progress had been made regarding the right to free, prior and informed consent, land demarcation and titling.²⁰³

104. JS19 noted that, according to indigenous peoples, the institutionalization of the Ley Organica de Consejos Comunales since 2009 has impeded communities' right to self-determination and their own forms of organisation.²⁰⁴ LABPAZ recommended that the State should refrain from interfering in the right of indigenous communities to freedom of association.²⁰⁵

105. APIVEN recommended developing a legal and institutional framework for consultations that provides for the full participation of indigenous peoples,²⁰⁶ and implementing the United Nations Declaration on the Rights of Indigenous Peoples and the ILO Indigenous and Tribal Peoples Convention, 1989 (No. 169).²⁰⁷

106. CIDOB called for greater participation of indigenous peoples on equal terms.²⁰⁸ ASOVILUZ recommended prioritizing policies designed to ensure full understanding of the ethnic groups living in the country.²⁰⁹ CCSAM recommended further developing the Guaicaipuro Mission.²¹⁰

107. APIVEN, JS33 and LabPaz made reference to the recommendation to expedite the process of land demarcation.²¹¹ JS33 stated that this recommendation has not been addressed.²¹² LabPaz indicated that only 12.4 per cent of indigenous lands have been demarcated.²¹³ APIVEN reported that the titles granted have been for individual communities rather than for entire peoples.²¹⁴

108. JS19 referred to violence surrounding land recuperation.²¹⁵ According to IHRC-OU, violent encounters have arisen because of disputes involving miners, indigenous peoples, and other locals with claims to indigenous lands.²¹⁶

109. OTSOAAM reported that ongoing illegal mining activity is damaging the habitat of indigenous peoples.²¹⁷ LABPAZ recommended carrying out consultation processes on extraction projects in indigenous territories.²¹⁸

110. APIVEN recommended establishing an intersectoral commission which includes indigenous persons among its members to design a strategy to fight illegal mining and the presence of illegal armed groups in indigenous territories.²¹⁹

13. Migrants

111. PROVENE made reference to a 2015 crisis during which the main borders with a neighbouring country were closed, affecting the legal situation of migrants from that country present in the Bolivarian Republic of Venezuela.²²⁰ HRW indicated that the security forces deported hundreds of refugees and persons from a neighbouring country living legally in the Bolivarian Republic of Venezuela close to the border.²²¹

14. Right to development and environmental issues

112. JS36 recommended devising a national adaptation plan to ensure sustainable human development in a context of climate change.²²² APIVEN recommended including indigenous peoples in the design of development models.²²³

113. ECO-UKAMAU recommended implementing a more vigilant environmental policy so as to ensure that transnational oil companies do not damage the environment.²²⁴
