**AIDE-MEMOIRE RELATING TO THE CANDIDACY OF TUNISIA  
TO THE HUMAN RIGHTS COUNCIL**

1. Tunisia's commitment to Human Rights, which has never ceased to gain strength, is rooted in its historic heritage and further reinforced by political will, strongly enhanced since November 7, 1987.
2. Tunisia, which has supported the establishment of the Human Rights Council, is convinced that this body will bring an important contribution to the strengthening of international achievements in the field of the Human Rights and will increase the international consensus regarding all aspects related to the promotion and the protection of all Human Rights.
3. Tunisia is party to all international and regional conventions on Human Rights and is fully associated to all endeavours by the United Nations Member States aimed at the promotion, protection and consolidation of the Human Rights. This commitment was materialised by the establishment, at the national level, of appropriate mechanisms for the promotion and dissemination of the culture of Human Rights through the enactment of a comprehensive legal framework in order to avoid any form of violation of Human Rights.
4. Tunisia has devised and implemented a Human Rights approach which is global, progressive and dynamic. Such an approach guarantees fundamental freedoms and Human Rights in their universal, global, complementary and interdependent dimensions.
5. Tunisia has adopted a number of measures aimed at strengthening the rule of law and insuring fundamental freedoms and rights of the human being, thus leading to a harmonious development of the individual and the society altogether. The promotion of democracy and political pluralism, supported by undisputed economic and social achievements and by a dynamic and active civil society, all made it possible for Tunisia to attain an advanced position among emerging countries on the human development scale.

6. The promotion and the protection of the rights of the woman and child as well as policies and programs extending to all social categories, with no exclusion, the benefits of development enjoyed by the country, make Tunisia among pioneer-states in ensuring social rights.
7. National policies, adopted by Tunisia since independence, in the promotion of the rights of woman and gender equality, guarantee that all components of the Tunisian society enjoy equal rights and equitable opportunities to reach personal fulfillment and to participate actively in the economic and social life.
8. Convinced that peace, security, development and Human Rights are interdependent and mutually reinforcing, Tunisia is, at the international level, party to instruments and convention on the promotion and protection of Human Rights and plays an active role within regional and international fora for the promotion of Human Rights. 9. Tunisia actively participates in the work of the United Nations and regional bodies dealing with Human Rights and cooperates with the United Nations Human Rights mechanisms. It has always honored its commitment to present its periodic reports under the conventions it has ratified.
10. Tunisia actively participates in regional and international efforts in order to make the values of tolerance, solidarity and dialogue among cultures and civilizations a reality, thus promoting understanding between peoples on the basis of respect for religions and beliefs.

(\*) Tunisia is party to the following main instruments:

- International Covenant on Economic, Social and Cultural rights
- International Covenant on Civil and Political rights
- Convention on the Right of the Child
- Optional protocols to the Convention on the rights of the child on the involvement of children in armed conflict, on the sale of children, child prostitution and child pornography
- Convention on the Elimination of all forms of Discrimination against Women
- Convention against Torture and other cruel, inhuman or degrading treatment or punishment
- Convention against Discrimination in Education
- Slavery Convention
- Protocol amending the Slavery convention of Dec. 7, 1953
- Convention on the Abolition of Slavery, the slave trade, and institutions and practices similar to slavery.

Tunisia, which has actively participated in the debate concerning the role of the newly established Human Rights Council, is firmly convinced that this body, which is of particular importance, will undoubtedly contribute to the promotion of a global and consensual approach to Human Rights on the basis of respect for human dignity and international law.
12. Tunisia will fully contribute to the efficient functioning of the Human Rights Council and to international efforts aimed at promoting the culture of Human Rights throughout the world.
