Executive Summary

This report reveals how UNRWA, despite its claims to be a humanitarian agency, has forged an unholy alliance with Hamas, Palestinian Islamic Jihad, and other terrorist organizations. This secret relationship allows the terrorist organizations to significantly influence the policies and practices of a UN agency with 30,000 employees, and a \$1.5 billion annual budget that is funded primarily by Western states.

The report shows how UNRWA's international officials, and its senior local managers, routinely meet with terrorist groups in Lebanon and Gaza, mutually praise each other for "cooperation," and describe each other as "partners."

The terrorist groups frequently make demands of UNRWA and influence its decisions. Moreover, when the terrorists oppose specific actions by UNRWA—such as the introduction of biometric IDs for beneficiaries of UNRWA financial assistance, an ethics code affirming LGBT rights, or suspension of employees for promoting terrorism—the terrorist groups are often able to foil implementation, including by issuing threats.

Examples of the UNRWA-Terrorist Alliance

Examples of the UNRWA-terrorist alliance, documented in the report below with 68 photos obtained from open sources, include:

UNRWA Commissioner-General Philippe Lazzarini made a deal with Jihadi terrorist groups, at a Beirut meeting in May 2024, by which UNRWA allowed Hamas leader **Fathi Al-Sharif** to remain as principal of a major UNRWA school, and as the head of the UNRWA Teachers Union. For years, Al-Sharif had openly glorified Hamas terrorist attacks, including on his Facebook page, and published photos of his fraternization with heads of terrorist organizations. Contrary to its claims of robust neutrality mechanisms, UNRWA for years allowed Al-Sharif to occupy a senior position overseeing thousands of UNRWA teachers and students. Only when a formal complaint was made to UNRWA by a government, in early 2024, did the agency give Al-Sharif a slap on the wrist by suspending him. Immediately, Hamas and other terrorist

groups responded by effectively shutting down UNRWA in Lebanon, mobilizing massive protests by UNRWA teachers and students. Three months into the shutdown, Lazzarini flew to Beirut and met with the alliance of terrorist organizations who were behind the strike. Local media reported on June 1, 2024, Lazzarini and the terrorist groups reached "understandings" that would lead to a "positive" result for Al-Sharif, and the strike was called off. On September 30, 2024, Al-Sharif was eliminated by an IDF missile. Hamas announced that indeed he had been their leader in Lebanon, and eulogized the senior UNRWA figure for his "Jihadi education."

- Former UNRWA Commissioner-General Pierre Krähenbühl met with terrorist leaders from Hamas and Palestinian Islamic Jihad, in February 2017, where he emphasized the "spirit of partnership" between them and UNRWA. He invited the terrorist leaders to privately challenge any UNRWA decision which he could then change or "tear up." The head of UNRWA urged the Jihadi terrorist groups to ensure that their "discussions not be made public" so as to avoid harm to UNRWA's "credibility." Mr. Krähenbühl, who was forced to leave UNRWA in 2019 due to a corruption and sexual abuse scandal, was this year absurdly appointed to head the International Red Cross, prompting a sharp protest by 17 members of the United States Senate.
- Likewise, in June 2022, current UNRWA chief Lazzarini stressed the importance of "partnership" with Gaza terrorist groups. He met regularly with Gaza terrorist groups under the umbrella of the "Joint Refugee Committee," which is headed by Mahmoud **Khalaf,** a member of the central committee of the Democratic Front for the Liberation of Palestine (DFLP), designated as a terrorist organization by the United States and the European Union.

- **Matthias Schmale,** the former UNRWA director in Lebanon, addressed a Hamas rally in August 2018 alongside Ali Baraka, one of six Hamas terrorist leaders indicted in September by the US Department of Justice, as the latter told the crowd that donor states must support UNRWA "until we return to Palestine." Schmale thanked the terrorist groups "for their understanding" and reassured them that UNRWA is on their side. In October 2020, now serving as UNRWA Director in Gaza, Schmale met with the Joint Refugee Committee headed by DFLP official Mahmoud Khalaf, to discuss "the problem of forcibly dismissed employees." In numerous such cases, local UNRWA staff suspended for links to terrorism were reinstated under pressure by the terrorist groups.
- Former Deputy Commissioner-General **Leni** Stenseth personally went to Gaza, in June 2021, to kowtow before Yahya Sinwar, the Hamas terror chief who masterminded the October 7th massacre. Hamas had been angry with UNRWA after its then Gaza Director Matthias Schmale, an ardent supporter of the Palestinian narrative, unwittingly admitted in a TV interview that Israeli strikes on Hamas, during the May 2021 war, were "very precise." The interview was widely shared by supporters of Israel. Outraged, Hamas declared Schmale a persona non grata, and orchestrated mob protests to threaten him. Stenseth obediently removed Schmale from his post, throwing him under the bus to appease Sinwar, and called Schmale's interview "indefensible." She went to visit Sinwar in Gaza to personally thank him "for his positivity and desire to continue cooperation in facilitating the agency's work in the Gaza Strip." Stenseth is now Director-General of the foreign ministry of Norway, UNRWA's most ardent state supporter. Stenseth uses her current position to fund groups that lobby for UNRWA, such as the Chr. Michelsen Institute, which was unethically chosen to conduct the "independent review" of UNRWA led by Catherine Colonna.

- UNRWA Lebanon Director **Dorothee Klaus** shared a stage with the leader of Hamas in Lebanon, Fathi Al-Sharif, who as noted above was also an UNRWA school principal and head of the UNRWA Teachers Union. At the event, before a cheering crowd, Al-Sharif proclaimed his support for "the resistance." Ms. Klaus did not object.
- UNRWA managers have participated at an annual Hamas conference which discusses internal UNRWA affairs such as employee vacancies and UNRWA Teachers Union elections. At the 2021 conference, Hamas official **Ahmad Abd Al-Hadi** announced the launching of a joint committee to "supervise the relationship with UNRWA and ensure it implements its obligations."
- In February 2018, former UNRWA Program Director in Lebanon **Gwyn Lewis** met with Hamas official Ahmad Fadl, and they agreed on "ongoing cooperation and coordination."
- UNRWA regional directors routinely meet with local terrorist leaders for "cooperation and coordination." At a November 2017 meeting, they told UNRWA's Sidon Director Fawzi Kassab that UNRWA must exist until Palestinian refugees "return to their homes" and threatened that if donors do not continue funding UNRWA, the Palestinians will start a "popular revolution."
- In January 2018, former UNRWA Labanon Director Claudio Cordone, who also previously served as acting chief of Amnesty International, met with Hamas official Ahmad Abd al-Hadi who affirmed that terrorists support UNRWA because it "remains a living witness to the 1948 Nakba." Likewise, in February 2022, Cordone visited Ain Al-Hilweh camp to meet with a coalition of terrorist groups, including Hamas, Islamic Jihad, and Ansar Allah. Hamas official Al-Hadi was also present at this meeting. The terrorists told Cordone that the Palestinian issue in Lebanon is "a political issue and cannot be reduced to a humanitarian or security issue." Contrary to what the world is told, UNRWA's main purpose is not humanitarian aid, but rather to promote the narrative that Israel's creation was an "injustice" and that the Palestinians will one day dismantle Israel.

In February 2017, former UNRWA Lebanon Director Hakam Shahwan told terrorist leaders that UNRWA was "fully prepared" to have "a strong partnership mechanism" with them, so long as the partnership should not reach a stage "where some believe that we are partners in decision-making."

Conclusions

This report reveals how UNRWA's senior management not only knowingly employ individuals tied to Hamas terrorism, but also allow the terrorist groups to influence critical agency decisions and policies.

UNRWA is an anomaly. While it was created by the United Nations and has "UN" initials in its title, it is essentially a Palestinian-run organization whose purpose is to perpetuate Palestinians as refugees with the aim to one day dismantle Israel. For Palestinians young and old, UNRWA is about enshrining the "right of return," which is to be achieved by "resistance." Leaders of Palestinian factions, as well as students of UNRWA schools, openly point to the October 7th Hamas invasion and massacre of Israelis as an example of what they

Funded almost entirely by Western countries, UNRWA acts as a state-like welfare agency providing dependent Palestinians with health care, education, and even cash assistance. As UNRWA's Commissioner-General readily admits, no other UN organization "has been geared to provide public-like services like UNRWA."1 In order to justify the "UN" initials in its name, UNRWA's Palestinian beneficiaries have been deemed "refugees" even though most do not qualify for refugee status under the 1951 Refugee Convention.²

The Agency has 30,000 employees, more than 99% of whom are "Palestine refugees." The Swiss head of UNRWA and the other international staff are those who represent and fundraise for the agency, but they amount to only 120 people, a mere

0.4% of UNRWA's entire workforce.⁴ All of UNRWA operations on the ground are run by the agency's local Palestinian staff. The regional directors, school principals, teachers, administrators, social workers, health care providers, and union heads are all local Palestinians. The role of the 120 international staff, including Commissioner-General Philippe Lazzarini, who is the public face of the agency, is to fundraise for UNRWA and to preserve its public image. They have little influence over UNRWA's day-to-day activities on the ground.

When UNRWA's most senior educators—like Fathi Al-Sharif in Lebanon and Suhail Al-Hindi in Gaza-are simultaneously UNRWA school principals, heads of the UNRWA Teachers Union, as well as Hamas leaders, it is clear who is truly in control. These are people who publicly proclaim their support for "the resistance," organize school activities that incite children to violence, and obstruct whatever minimal efforts are made by UNRWA international staff to discipline employees for promoting terrorism, downplayed as mere "neutrality violations." According to Israeli intelligence, more than 10 percent of UNRWA's senior educators in Gaza are members of the Hamas and Palestinian Islamic Jihad terror groups.5

UNRWA's international staff, led by Lazzarini, spend much of their time trying to appease the local terror groups who are on the ground at UNRWA facilities. The end result is that Lazzarini and his colleagues knowingly allow Hamas and other terrorist groups to infiltrate UNRWA's employee base, indoctrinate impressionable Palestinian children to pursue a path of Jihadi terrorism against Israelis and Jews, and install military infrastructure underneath or next to UNRWA facilities.

Occasionally, when revelations of staff promotion of terrorism embarrass UNRWA and its Western donor states, the international staff make a show of "enforcing neutrality." This is what caused UNRWA, in January 2024, to create a so-called "independent review" of UNRWA neutrality, a process which in

fact was rigged to provide a clean bill of health.⁶ Since the fraudulent report was published in April 2024, Lazzarini has been boasting to donors that "the Independent Review of UNRWA's neutrality found that the agency has a more robust approach to neutrality than comparable entities."⁷

At the same time, when UNRWA belatedly attempted to discipline Fathi Al-Sharif in February 2024, despite his Hamas activities being widely publicized for years, including on Al-Sharif's own Facebook page, UNRWA's Lebanon Director Dorothee Klaus met severe resistance. As noted above, the entire UNRWA system in Lebanon rallied behind Al-Sharif. Local terrorist leaders, working with the local UNRWA Teachers Union headed by Al-Sharif, orchestrated three months of massive protests, making it impossible for UNRWA to operate. UNRWA never fired Al-Sharif. Instead, Lazzarini maintained for months that Al-Sharif was suspended and "under investigation," i.e., he continued to receive his UNRWA benefits. Eventually, on September 30, 2024, Al-Sharif was killed in a targeted Israeli airstrike. UNRWA may have a "robust neutrality approach," but it is unwilling and unable to enforce it.

The fact that Lazzarini has spent the last 14 months since October 7, 2023, shirking any responsibility by UNRWA for the atrocities perpetrated against Israelis by Hamas terrorists, including the involvement of UNRWA employees in those atrocities and in the ongoing hostilities in Gaza, shows that he is more focused on preserving UNRWA's image than on ensuring its neutrality and independence. As the head of a UN agency obligated to the humanitarian principles of humanity, neutrality, and impartiality, Lazzarini should swiftly take responsibility for any wrongdoing by his agency and its employees, act decisively to prevent future violations, and completely repudiate Hamas and its fellow Palestinian terrorist groups. Instead, he constantly works to appease the terrorists.

UNRWA's failure to maintain neutrality, combined with its susceptibility to influence from terrorist groups, undermines its credibility as a humanitarian agency and perpetuates conflict in the region. In the words of Swiss foreign minister Ignazio Cassis, UNRWA "supplies the ammunition to continue the conflict," and "by supporting UNRWA, we keep the conflict alive. It's a perverse logic." It is time for donor states to put an end to this perverse logic, by dismantling UNRWA, and working together to provide alternative frameworks to help Palestinians build a better future for themselves and for the world.

1 Philippe Lazzarini UNRWA Commissioner-General (2019-present)

Lazzarini Meets With Hamas Leader Hajj Izzat Mansour

Lebanon, March 2019

In March 2019, when current UNRWA Commissioner-General Philippe Lazzarini was serving as the UN Special Coordinator for Lebanon, he met with Hamas Leader in Baalbek Hajj Izzat Mansour.⁸ Mansour had previously met with UNRWA's local officials in Baalbek to discuss vacant teacher positions and call on UNRWA to quickly fill the vacancies, suggesting Hamas influence over UNRWA's hiring decisions.⁹



Who is Hajj Izzat Mansour?

Mansour is the head of Hamas in the Baalbek region of Lebanon. In 2010, he was targeted by Fatah in an explosives attack due to his more radical approach to Israel. He frequently represents Hamas at rallies and events, where he delivers fiery speeches defending the right of return, praising Palestinian

factions for their "unity" and "resistance," and inciting against the "Zionist enemy." He has also spoken at events held at UNRWA schools to express solidarity with Palestinian terrorists. After the Oct 7 Hamas attack, Mansour joined rallies in support of Hamas "victory" in Gaza. 14

Lazzarini Meets With Palestinian Joint Action Committee

Lebanon, March 2021

In March 2021, Lazzarini visited Ein el-Hilweh camp in Lebanon for the first time as Commissioner-General.15 While there, he met with leaders of the "Palestinian Joint Action Committee" for an "extensive meeting" to discuss, among other things, providing Palestinian refugees in Lebanon with "direct financial assistance on a monthly basis." The Palestinian Joint Action Committee stressed that UNRWA is "a living witness to the Palestinian refugee issue" and that UNRWA is "concerned with the relief and employment of Palestinian refugees until the right of return is achieved."16

While the distribution of cash assistance to refugees was already ongoing, the terrorist groups insisted on raising the amount while simultaneously rejecting a proposal to use biometric data to ensure an accurate headcount of those receiving the assistance in the camp.¹⁷ Bowing to this pressure,

UNRWA continually delayed the biometric verification of their census data which determines how much cash flows into the camps.

In August 2023, Dorothee Klaus announced the project would finally be launched but with no clear timeline. 18 Terrorist leaders adamantly oppose implementation of the project. Speaking in the name of the Joint Palestinian Action Committee in Lebanon, Hamas's Ayman Shana'a told UNRWA of the group's "complete rejection of this project." 19 These groups have an obvious interest in keeping the number of beneficiaries inflated as it gives them access to more untraceable cash for their operations.

Since the meeting was held during COVID many in the photos are unidentifiable behind masks. However, one individual stands out for his glasses and beard, Jamal Khattab, Sheikh of the Palestinian Jihadi Movement.²⁰ The only other identifiable individual is Hajj Abu Suleiman Al-Saadi, an official of the Asbat al-Ansar terrorist group.

What is the Palestinian Joint Action Committee?

This Committee is a consortium of armed Palestinian groups in Lebanon, including the Palestinian Liberation Organisation (PLO), Hamas, Palestinian Islamic Jihad (PIJ), Popular Front for the Liberation of Palestine (PFLP), Democratic Front for the Liberation of Palestine (DFLP), Ansar Allah, Popular Struggle Front, Vanguard of the Popular Liberation War, Saiqa Forces, and Asbat al-Ansar, a UN-designated terrorist group with links to Al-Qaeda. It was established as an initiative for Fatah and Hamas to put aside their differences and join forces in the face of U.S. action against UNRWA in order to ensure the continued existence of UNRWA and the preservation of the so-called "right of return."21 The Committee is led by the domestic leaders of each terrorist group including Ali Faisal (DFLP), Ahmad Abd Al-Hadi (Hamas), Jamal Khattab (Palestinian Jihad), and Haitham Abdul Karim Al-Saadi (Asbat al-Ansar).

Who is Jamal Khattab?

Jamal Khattab is an UNRWA graduate who worked for UNRWA in different capacities, including as a financial officer from 1987 until at least 1994. At the same time, Khattab joined the Islamic Jihad (Mujahideen) Movement as a child in the 1970s, fought against Israel in the 1980s, rose in the ranks to the movement's leadership committee in 1982, and became its first official in 1996. Thus, Khattab was active as a Palestinian Jihadi leader the entire time he was employed by UNRWA. Khattab was also secretary of the Palestinian Islamic Forces which includes groups such as Hamas, Ansar Allah, and Asbat al-Ansar. Khattab believes that "all of historical Palestine belongs to the Palestinian people" and that Palestinian refugees have a "right" to "return to their homes from which they were displaced." He also believes that "the option of resistance is a duty to deal with the occupation, and liberation cannot be achieved without armed jihadist action."22

Who is Hajj Abu Suleiman Al-Saadi?

Hajj Abu Suleiman Al-Saadi is an official for Asbat al-Ansar, a UN-designated terrorist group linked to al-Qaeda.²³ Asbat al-Ansar is also designated as a terrorist group by Bahrain, Canada, Kazakhstan, Russia, the UAE, the United Kingdom, and the United States. The goal of the group is "the establishment of a radical Islamic state in Lebanon."24 Hajj Abu Suleiman Al-Saadi appears as an official representative of the organization in various meetings with other terrorist groups.²⁵

Lazzarini Meets with Ali Ahmad Huwaidi

Lebanon, December 2021

On December 8, 2021, Ali Ahmad Huwaidi met with Philippe Lazzarini and Claudio Cordone at UNRWA's Beirut headquarters on the sidelines of Hamas's annual summit on UNRWA.26 At this summit, leaders of various terrorist groups discuss how to manage UNRWA and align their goals with one another. The meetings are always attended by an UNRWA regional director who reads statements on behalf of the UNRWA Director-General. Ali Ahmad Huwaidi also regularly attends these meetings as he did in December 2021.27

At the meeting with Lazzarini and Cordone, Huwaidi expressed concern about UNRWA's financial crisis and emphasized the need to pressure donors to continue funding UNRWA. He implied that should the funding dry up and UNRWA cease to exist this would lead to military confrontation which would end up costing donors more than the amount of their funding to UNRWA.

Who is Ali Ahmad Huwaidi?

Huwaidi is known for his participation in Abu Shaker Cubs, a group of UNRWA students who fought against Israel in the 1982 Lebanese War. He promotes the Hamas position that "the right of return" means return to the territory of the sovereign State of Israel and replacing it with a Palestinian state.²⁸ He is now Director General of the "302 Committee for the Defense of Refugee Rights," an UNRWA lobbying group in Lebanon whose main goal is to instill at UNRWA Hamas's "Right of Return through resistance" philosophy.29

Lazzarini Meets With Palestinian Forces Alliance

Lebanon, December 2023

In December 2023, just two months after the October 7 attack, Lazzarini traveled to Ein el-Hilweh camp in Lebanon to meet with the "Palestinian Forces Alliance." During his visit, Lazzarini met with "representatives of the popular committees of the PLO factions, the Palestinian Forces Alliance, and the Islamic forces." Hamas Political Relations Officer Khaled Zuaiter handed Lazzarini a memorandum on behalf of the Palestinian Forces Alliance stipulating their demands for increased financial assistance. 32

What is the Palestinian Forces Alliance?

The Palestinian Forces Alliance is a coalition of armed groups that predates the "Palestinian Joint Action Committee" and includes the same terrorist groups except for Fatah/PLO forces. Despite infighting between the terror groups and Fatah, the Palestinian Forces Alliance and the Palestinian Joint Action Committee continue to work together on UNRWA issues.³³

Who is Khaled Zuaiter?

Khaled Zuaiter is the political official and leader of Hamas in the Ain al-Hilweh camp. Zuaiter is a public face representing Hamas in meetings with Hezbollah³⁴ and other officials to give "detailed explanations of the battle of al-Aqsa flood" and coordinate joint initiatives on UNRWA.³⁵

Lazzarini Meets with Terrorist Coalition

Lebanon, May 2024

In May 2024, Lazzarini traveled to Beirut to resolve mass protests that had shut down UNRWA's Beirut headquarters over UNRWA's suspension of Lebanon Teachers Union head Fathi Al-Sharif, also a key leader in Hamas. Lazzarini met and negotiated with the main protest leaders, who were representatives of terrorist groups including the Palestinian Forces Alliance, Islamic Forces, and Ansar Allah.³⁶

After the meeting, local press reported that the negotiations led to the matter being resolved in a "positive manner." One news outlet, commenting on the negotiations, indicated that the relationship between Lazzarini and the terrorist leaders had "become tense," confirming that previously Lazzarini and these terrorists had enjoyed a cooperative working relationship.38

Lazzarini Meets with the Joint **Refugee Committee**

Gaza, June 2022

In Gaza, Lazzarini also regularly meets with terrorist leaders.³⁹ In June 2022, Lazzarini and UNRWA Gaza Director Thomas White met with the Joint Refugee Committee, which is coordinated by the DFLP's Mahmoud Khalaf. They discussed matters affecting the refugees, including hiring employees. At the end of the meeting, the two sides stressed the need to "continue meetings" and the importance of their "partnership."40


What is the Joint Refugee Committee?

The Joint Refugee Committee is a consortium of local leaders who created a joint coordination body to engage with UNRWA.41 They organize protests and regularly meet with UNRWA officials to advocate on behalf of the groups they represent. The committee has on several occasions contested UNRWA's neutrality policies and strongly opposed disciplinary actions against employees based on these policies, stating that it will "confront in all possible ways this campaign" which is "in service of the Zionist enemy."42 The Committee has also demanded "an end to all forms of extortion to which they [UNRWA employees] are subjected under the slogan of neutrality."43

In September 2023, one month before the October 7th attacks, this Committee published a statement vehemently rejecting UNRWA's new code of conduct due to provisions about gender equality and LGBT rights. The Committee opposed this change because it "flagrantly violates the feelings of refugees and employees, calls for vice, and belittles all the customs, traditions, struggle, and history of our Palestinian people." The Committee, along with the UNRWA Gaza Employees Union, stated that "the so-called gay rights are completely rejected and have no place in our Palestinian society."44

Who is Mahmoud Khalaf?

Mahmoud Khalaf is a senior member of the Democratic Front for the Liberation of Palestine (DFLP), coordinator of the Joint Refugee Committee, and a member of the leadership of the National and Islamic Forces.⁴⁵ The DFLP is a terrorist organization that split from the PFLP in 1969, It is best known for its terrorist attacks against Israeli civilians in the mid-1970s.46 More recently, the DFLP took part in the October 7th attacks. 47 The National and Islamic Forces include terrorist groups such as Hamas, PIJ, and the PFLP.48

Lazzarini Meets With Joint Refugee Committee

Gaza, February 2023

The Joint Refugee Committee met with Lazzarini and UNRWA Gaza Director Thomas White in February 2023, making various demands relating to UNRWA's services. The Committee emphasized the importance of "communication" with UNRWA "in order to resolve all pending issues in the service of the refugee community."49

Lazzarini Meets With Joint Refugee Committee

Gaza, July 2023

In a July 2023 meeting with Lazzarini, the Joint Refugee Committee discussed the details of UNRWA's services including decisions affecting education and healthcare.50 When Mahmoud Khalaf is absent during meetings between UNRWA and the Joint Refugee Committee, his deputy, Basil Al-Wahidi, takes his place.

Who is Basil Al-Wahidi?

Basil Al-Wahidi is a senior Popular Front for the Liberation of Palestine (PFLP) member, and Khalaf's deputy in the Joint Refugee Committee.⁵¹ The PFLP is designated as a terrorist group by the United States, Japan, Canada, and the European Union. It is famous for a series of airplane hijackings in the 1960s and 70s, suicide bombings, and the assassination of Israeli Tourism Minister Rahavam Ze'evi in 2001.52 More recently, the PFLP participated in the October 7th attacks.53


Krähenbühl Meets With Multiple **Terrorist Leaders**

Lebanon, February 2017

In February 2017, former UNRWA Commissioner-General, Pierre Krähenbühl, met with various terrorist leaders including Ali Baraka (Hamas), Abu Imad Al-Rifai (Palestinian Forces Alliance), Ali Faisal (DFLP), Salah Al-Youssef (PLF), Abu Imad Ramez (Popular Front - General Command), and Hassan Zeidan (Fatah al-Intifada).54

In this meeting, Faction leaders urged Krähenbühl to enhance UNRWA services, maintain its mandate and address problems such as overcrowding in camps, unemployment, healthcare, education and housing. Krähenbühl asserted the necessity of continued coordination with the groups on a variety of issues and promised to continue holding as many meetings as they would like to ensure a "spirit of partnership." He also requested that the partnership and meetings not be made public so as to not risk the "loss of trust between the funding countries and UNRWA, which may move towards reducing or stopping its funding." Here is his full quote:

"I hope that the spirit of partnership will be in both directions, that is, if you have any criticisms, comments, concerns or any matters that you are not satisfied with regarding UNRWA, that we return and hold such meetings even if we meet a thousand times and if you challenge our decisions and if you tell us that we do not want this decision and criticize it, we may change it or tear it up, but that the spirit of partnership prevails among us in our meetings and not be public because this is a challenge to us and our credibility, and what is more dangerous is what this could constitute in terms of a loss of trust between the funding countries and UNRWA, which may move towards reducing or stopping its funding. The issue of your cooperation with us in security aspects and not allowing the closure of UNRWA institutions, facilities, schools or offices, lies in the partnership between us, and if we reach that, it means that we are united and no one can separate us."

Who is Ali Baraka?

Ali Baraka is the Head of Foreign Relations for Hamas and one of seven top Hamas leaders sanctioned by the U.S. and U.K. for "heinous crimes."55 Baraka managed Hamas ties with Tehran and other regimes including Syria and Iraq.⁵⁶ Days after the Hamas October 7th massacre, Baraka claimed that the group had been planning the attack for two years. "We made them think that Hamas was busy with governing Gaza, and that it wanted to focus on the 2.5 million Palestinians there, and has abandoned the resistance altogether. All the while, under the table, Hamas was preparing for this big attack," said Baraka.57

Who is Abu Imad Al-Rifai?

Abu Imad al-Rifai is the leader of Palestinian Islamic Jihad (PIJ) in Lebanon. PIJ is an offshoot of the Muslim Brotherhood and is funded by Iran. It has been designated a terrorist organization by the United States, the European Union, the United Kingdom, Canada, Australia, and New Zealand for countless suicide bombings and attacks.⁵⁸ The organization also participated in the October 7th atrocities. In 2003, Al-Rifai boasted about sending a wave of suicide bombers to Baghdad to kill American and British troops.⁵⁹

Who is Ali Faisal?

Ali Faisal joined the DFLP when it was founded in 1969 and quickly rose in the ranks to hold senior positions. In 1971, soon after joining the DFLP, Faisal also began working as a teacher at UNRWA's Al-Fidaa School where he continued to work until 1984.60 As a senior DFLP member in the 1970s and 80s, Faisal oversaw some of the DFLP's largest terrorist attacks, including the 1974 Ma'alot massacre in which 28 Israelis were killed. Faisal endorsed the wave of Palestinian terror attacks in 2015 and called a meeting to "build a unified resistance in the Gaza Strip to form a support for the intifada."61 As noted above, the DFLP later participated in the October 7th attack.

Who is Salah Al-Youssef?

Salah Al-Youssef was the leader of the Palestine Liberation Front (PLF) in Lebanon. After studying in UNRWA schools, he joined the PLF youth group when he was 12 years old and rose in the group's hierarchy to hold leadership positions. Al-Youssef opposed the Oslo Accords and supported resistance in all its forms.⁶² He died in 2022.⁶³ The PLF is likewise committed to armed resistance and has perpetrated a number of terrorist attacks, most notably the hijacking of the Achille Lauro Italian cruise ship in 1985.64 The organization has since been designated as a terrorist group by the US, Canada, and Japan.65

Who is Abu Imad Ramez?

Abu Imad Ramez (aka Ramez Mustafa) is the Leader of the PFLP-General Command, a splinter group from the PFLP with links to Syria's deposed Basher Assad, the Iranian regime, and Hezbollah. It is also a designated terrorist organization by the US, Canada, Japan and the EU.66 It is responsible for a number of terrorist attacks, including the 1970 bombing of Swissair Flight SR330, killing all 47 passengers and crew.⁶⁷ More recently, Abu Imad has endorsed stabbing and shooting attacks on Israeli civilians in response to possible normalization between Israel and Saudi Arabia in 2020.68 The PFLP-GC has also been fighting alongside Hamas since the 7th of October.69

Who is Hassan Zeidan?

Hassan Zeidan is a leader of Fatah al-Intifada, a hard-line terrorist group that splintered off from the original Fatah party in 1983, believing in the "liberation of Palestine by both armed struggle and armed resistance."70 The group has vowed armed resistance alongside Hamas in Lebanon for years,71 and has been fighting alongside Hamas in Gaza since October 7th.72

Pierre Krähenbühl Meets With Hamas's Abdul Majeed Al-Awad

Lebanon, February 2019

On February 12, 2019, former UNRWA Commissioner-General Pierre Krähenbühl and former UNRWA Lebanon Director-General Claudio Cordone met with Hamas Political and Media Relations Officer in Lebanon Abdul Majeed Al-Awad during a visit to UNRWA's Al-Qadisiyah School in the Rashidieh Camp near the city of Tyre in southern Lebanon. The subcommittee of the Palestinian factions, which includes the terrorist groups, submitted a memorandum to Krähenbühl demanding freedom of movement, public service improvements, and lifting restrictions on the types of building materials that can be imported.⁷³

Who is Abdul Majeed Al-Awad?

Al-Awad was elected as the political official of the Hamas movement in the Tyre region in 2017.⁷⁴ Today, he is Hamas's political and media relations officer in Lebanon who joins Hamas delegations to meet with ambassadors from Iran,⁷⁵ Venezuela,⁷⁶ and Russia.⁷⁷ He is a key coordinator between Hamas and Hezbollah⁷⁸ and has been instrumental in their coordination since October 7th.⁷⁹

Pierre Krähenbühl Meets With **Hamas and Other Terrorist** Leaders

Lebanon, February 2019

That same day, Pierre Krähenbühl, Claudio Cordone, and staff officer Hakam Shahwan also met with Ayman Shana'a, Hamas Head of National Relations in Lebanon, Khaled Zuaiter, Hamas political relations officer (discussed above under Lazzarini), and Jamal Khattab, Sheikh of Islamic Jihad (Mujahideen) in Lebanon (discussed above under Lazzarini).

In the meeting, Shana'a stressed the importance of "considering the Palestinian factions as a basic partner for UNRWA in preserving the dignity of our people and our camps with all the meanings they symbolize." Considering the "Palestinian factions" — terrorist groups like Hamas, PIJ, and the PFLP - as "partners" with UNRWA shows how these terrorists view UNRWA as advancing their own agenda of violent resistance.80

Who is Ayman Shana'a?

Shana'a, raised and taught in UNRWA schools, is the Head of National Relations for Hamas in Lebanon.81 Since October 7th, he has actively recruited hundreds of young people for Hamas military operations.82

Claudio Cordone Meets With Terrorist Leaders

Lebanon, 2017

In 2017, former UNRWA Lebanon Director Claudio Cordone and former UNRWA Deputy Director of Programs Gwyn Lewis met with Ali Baraka (Hamas), Abu Imad Al-Rifai (Palestinian Islamic Jihad in Lebanon), Ali Faisal (DFLP), Rafiq Ramidh (Fatah al-Intifada), and Hassan Zeidan (Fatah al-Intifada).83 Most of these terrorists were discussed above under Krähenbühl.



Claudio Cordone Meets With The DFLP's Ali Faisal

Lebanon, 2017

That year Cordone also met with the DFLP's Ali Faisal to discuss "all aspects of the services provided by UNRWA to Palestinian refugees in Lebanon and Palestinian refugees from Syria, including health, education, and relief."84

Claudio Cordone Meets With Hamas's Ahmad Abd Al-Hadi

Lebanon, January 2018

In January 2018, Cordone met with Hamas's Ahmad Abd Al-Hadi. At the meeting, the terrorists "stressed their adherence to the agency and their support for the 'Dignity is Priceless' campaign because the agency remains a living witness to the 1948 Nakba."85

Who is Ahmad Abd Al-Hadi?

Al-Hadi has been the representative of Hamas's International Leadership in Lebanon since 2018. He has been affiliated with the Muslim Brotherhood in Lebanon since 1990 and has held leadership positions in Hamas since 2003.86 In his current position, Al-Hadi represents Hamas in countless high level meetings, including with ambassadors from Cuba,87 the UN Envoy for Middle East peace,88 and Iran's intelligence minister.89

Claudio Cordone Meets With Hezbollah's Hassan Hoballah

Lebanon, August 2018

In August 2018, Cordone met with Hezbollah Political Council member, Hassan Hoballah, to discuss the pressures UNRWA is under to cancel refugee status for those born after 1948. Hoballah stressed that "UNRWA is the only witness to the barbarism of the Zionist occupation since 1948" and accused the U.S. administration of trying to end UNRWA "in preparation for dropping the right of return of Palestinian refugees to their land, homes and homeland, Palestine."90

Who is Hassan Hoballah?

Hassan Hoballah is the Hezbollah official in charge of Palestinian relations. In a January 2024 interview, he revealed that Hamas fighters were "trained in Lebanon, Syria and Iran." He also said that Hezbollah "has an alliance with the Palestinian resistance on every level" and therefore "aids the Palestinian resistance with everything it has," including "weapons and training."91

Lebanon, May 2020

On May 9, 2020, Ali Faisal (DFLP) (discussed above under Krähenbühl) met with Claudio Cordone to secure more cash assistance for Palestinians in Lebanon.93

A few days later, on May 13, 2020, the Palestinian Forces Alliance, including Ahmad Abd Al-Hadi (Hamas), attended a briefing by Claudio Cordone regarding UNRWA's corona-related assistance. The Palestinian delegation criticized UNRWA's proposed financial assistance because it did not cover individuals without identification documents.94

Claudio Cordone Meets With Palestinian Forces Alliance

Lebanon, February 2022

On February 14, 2022, Claudio Cardone accompanied the head of the Lebanese-Palestinian Dialogue Committee, Basil Al-Hassan, and several government ministers to Ain al-Hilweh camp in Lebanon to reassure the factions that the "Lebanese government will do its utmost to enhance cooperation and coordination with the Palestinian forces." Al-Hassan emphasized the need to "strengthen the

framework" of "cooperation and coordination with all concerned parties"-meaning both UNRWA and the terrorist factions—to aid the Palestinians in Lebanon and to "alleviate their suffering until their goals and legitimate national rights to return to their land and homeland are achieved.95

The "most important stop on the tour" was a meeting in Martyr Naji al-Ali Hall with members of the Palestinian Joint Action Committee in the Sidon area, which includes the Palestinian Forces Alliance headed by Hamas, the Islamic Forces, Ansar Allah, and others. Ayman Shana'a (Hamas) and Sheikh Jamal Khattab of Islamic Jihad (Mujahideen) (both discussed above under Lazzarini) were at the meeting as members of the Palestinian Alliance Forces. They stressed that "the issue of the Palestinian people in Lebanon is a political issue and cannot be reduced to a humanitarian or security issue."96

Dorothee Klaus

UNRWA Director-General in Lebanon (2023-present)

Dorothee Klaus Meets DFLP Leaders

Lebanon, September 2023

The DFLP through its Department of UNRWA affairs has regular meetings with UNRWA's Director in Lebanon. In September 2023, Current UNRWA Director-General in Lebanon, Dorothee Klaus, met with DFLP Leaders Arkan Badr (DFLP Deputy) and Ali Faisal (Deputy Secretary-General) (discussed above under Krähenbühl) who pressured UNRWA to increase funding and services for Palestinians in Lebanon. The DFLP affirmed "its adherence to UNRWA as one of the centers of the right of return." 97





Who is Arkan Ahmed Badr?

Arkan Badr is an UNRWA graduate, who joined the DFLP's youth organization as a student in the 1980s. Over the years, he rose in the DLP leadership and became a member of the political bureau in 2019. In the 1980s and 90s, when the DFLP was carrying out devastating terror attacks against civilians, Badr was involved in recruiting students to the cause. He believes that "all of historical Palestine belongs to the Palestinian people," endorses "the right of return of refugees to their homes and properties," and calls for "dismantling the Zionist movement as a racist movement."98

Ahmed Fadl is the Hamas official in charge of refugee and labor affairs in Lebanon. He was also a friend of Ismail Haniyeh and took up arms for Hamas.¹⁰⁴ About the Hamas October 7th attack, Ahmed Fadl stated that the "bravery of the resistance opened the door to liberation and return." 105

Matthias Schmale Meets With Hamas's Ali Baraka

Lebanon, November 2015

In November 2015, former UNRWA Director-General in Lebanon Matthias Schmale met with Ali Baraka (Hamas) (discussed above under Krähenbühl). The Hamas delegation objected to UNRWA's decision to cut costs in education by combining classes as this resulted in teachers losing their jobs. The Hamas representatives stressed that UNRWA's job is to provide relief and employment to Palestinian refugees "until they return to their homes."106



Matthias Schmale Meets With Hamas's Jihad Taha and Hajj Abu Samer Musa

Lebanon, May 2015

In May 2015, Schmale was also received by Hamas's Jihad Taha and Hajj Abu Samer Musa in Tyre. After the meeting, Schmale was taken on a tour which featured armed men dressed in civilian clothing.107

Who is Jihad Taha?

Jihad Taha is an international spokesman for Hamas based in Lebanon and one of Hamas's top leaders. He is the most public face of Hamas in Lebanon, appearing in the media worldwide to provide updates on topics such as selecting Yahya Sinwar to succeed Ismail Haniyeh¹⁰⁸ and ongoing ceasefire negotiations.¹⁰⁹ On World Refugee Day (June 20, 2024), Taha stressed that "there will be no compromise on the right of all refugees from our people to return to their homes from which they were forcibly displaced, and our people will continue their comprehensive resistance until they seize all their rights and end the fascist Zionist occupation."110



Who is Hajj Abu Samer Musa?

Abu Samer Musa is a Palestinian Islamic Jihad (PIJ) official in Lebanon responsible for Palestinian relations. In October of 2024, Abu Samer Musa reiterated PIJ's commitment to violent resistance stating, "The martyrs are the most honorable of us all, and their pure, innocent blood will slap all those who conspire against our people and our nation, and the Islamic Jihad Movement will continue its role in the resistance."111 At a ceremony honoring him, Abu Samer Musa stated "we will liberate our land from the river to the sea through resistance" and "negotiations do not succeed with the enemy."112 Abu Samer Musa also describes the Hamas October 7 attack as a "miracle" and boasts that since that attack the PIJ and the Houthis in Yemen have had continuous communications, adding that "coordination is at its highest levels and matters are managed wisely."113

Matthias Schmale Speaks at Terrorist Rally Along With Hamas's Ali Baraka

Lebanon, August 2018

On August 5, 2018, terrorist groups organized a sit-in at UNRWA's Beirut headquarters to protest potential service cuts by UNRWA and to demand increased funding. Hamas's Ali Baraka (discussed above under Krähenbühl) delivered remarks on behalf of Hamas and the Palestinian Forces Alliance demanding that the international community support UNRWA "until we return to Palestine," adding "we want to return to Palestine, Galilee and Jerusalem."

Schmale also spoke to thank the terrorist groups "for their understanding of the issue and taking to the streets to express their demands" and to reassure them that UNRWA is on their side. "UNRWA will remain the living witness to the issue of Palestinian refugees," he said.114



Mathias Schmale Meets with DFLP's Mahmoud Khalaf

Gaza, June 2020

In October 2020, in his capacity as UNRWA Gaza Director, Schmale met with Mahmoud Khalaf (DFLP) (discussed above under Lazzarini) and his colleagues in the Joint Refugee Committee to discuss UNRWA's activities in Gaza. At the meeting, Schmale stressed the importance of keeping UNRWA "as a living witness to the Palestinian refugee issue." The Committee made various demands on UNRWA regarding employee hiring.¹¹⁵

The Committee submitted a memorandum criticizing UNRWA's services and seeking to resolve "the problem of forcibly dismissed employees," i.e., employees subjected to disciplinary proceedings. 116

Hakam Shahwan Meets With Hamas's Jihad Taha and Hajj Abu **Samer Musa**

Lebanon, November 2016

In November 2016, former Director-General of UNRWA in Lebanon Hakam Shahwan visited Rashidieh camp in Tyre to discuss issues facing Palestinian refugees in Lebanon. During the visit, he met with Hamas's Jihad Taha and Hajj Abu Samer Musa (both discussed above under Schmale).¹¹⁷

Hakam Shahwan, Gwyn Lewis and Pierre Krähenbühl Host **Terrorist Leaders at UNRWA's Beirut Headquarters**

Lebanon, February 2017

On February 14, 2017, Hakam Shahwan, Gwyn Lewis, and Pierre Krähenbühl hosted leaders of various terrorist groups at the UNRWA headquarters in Beirut. At the meeting, Shahwan told the terrorist leaders that "the main message" he wishes to convey while touring the camps and meeting the various terrorist factions is that UNRWA is "fully prepared to have a strong partnership mechanism between us and them, but the rule is that this partnership should not reach a stage where some believe that we are partners in decision-making..."118

Shahwan confirms a "strong partnership mechanism" between these terrorist groups and UNRWA. At the same time, he is keenly aware of the optics of this partnership for international donors and therefore asserts that they can not allow donors to "believe" that UNRWA and the terrorist groups "are partners in decision-making." Following this introduction, Shahwan listed a variety of projects that UNRWA and the terrorist groups had jointly agreed to implement.

8 Thomas White UNRWA Gaza Director (2021-2024)

Thomas White Meets with DFLP's Mahmoud Khalaf

Gaza, August 2022

Thomas White meets with the Joint Refugee Committee in Gaza regularly, sometimes alongside Philippe Lazzarini. As noted above under Lazzarini, the committee is headed by DFLP member, Mahmoud Khalaf (discussed above under Lazzarini) who also coordi-



nates the National and Islamic Forces, which include terrorist groups such as Hamas, PIJ, and PFLP.

In an August 2022 meeting, White assured the Joint Refugee Committee that UNRWA would add an additional $60,\!000$ Gazans as UNRWA beneficiaries within the next year, including newborns and spouses. The Committee reiterated the need for UNRWA to hire more staff. ¹¹⁹

Thomas White Meets with DFLP's Mahmoud Khalaf

Gaza, December 2022

In a December 2022 meeting White and the Joint Refugee Committee discussed a number of issues affecting the refugees, including the need to hire more employees. At the end of the meeting, "the importance of joint work and cooperation between UNRWA and the Joint Refugee Committee was emphasized." ¹²⁰

Leni Stenseth Pledges Allegiance to Hamas Gaza Chief Yahya Sinwar

Gaza, June 2021

On June 2, 2021, UNRWA Deputy Commissioner-General Leni Stenseth met with Hamas Gaza chief Yahya Sinwar to denounce recent statements made by then-UNRWA Gaza Director Mathias Schmale and his deputy in a TV interview where they stated that IDF strikes on military installations in Gaza during the May 2021 conflict were "very precise." ¹²⁴

While condemning Schmale's remarks, described as a "dangerous transgression," 125 Sinwar stressed "the pride of our people in general, and its factions, especially Hamas, in particular, in the positive and constructive relationship with UNRWA and the historical role it played in strengthening the steadfastness of our people and establishing their rights." He further emphasized Hamas's keenness to "continue cooperation with UNRWA and facilitate its mission." 126

During the meeting, Stenseth apologized for Schmale's statements as completely indefensible. She thanked Sinwar "for his positivity and desire to continue cooperation in facilitating the agency's work in the Gaza Strip." The meeting concluded with both parties stressing the need for "direct communication and dialogue" and "cooperation." ¹²⁷

12 UNRWA Regional Directors in Lebanon

Regional directors are the operational leaders of UNRWA in the field and are the individuals on the ground who actually run UNRWA. These regional directors all have close partnerships with local terrorist leaders. They are the ones who facilitate the meetings between these terrorist leaders and UNRWA's international staff.

UNRWA Regional Directors Meet Hamas Leader Ali Baraka

Lebanon, December 2014

In December 2014, all of UNRWA's regional directors in Lebanon met Hamas Leader Ali Baraka to congratulate him on the twenty-seventh anniversary of the launch of the Hamas Movement and to stress "the importance of cooperation and coordination." Present at the meeting were, Muhammad Khaled (Director of the Beirut Region), Ibrahim Al-Khatib (Director of the Sidon Region), Fawzi Kassab (Director of the Tyre Region), and Ahmad Moh (Director of the Bekaa Region). 128

UNRWA Regional Directors Participate in Annual Hamas UNRWA Summit

Hamas holds a yearly summit along with other terrorist groups to discuss UNRWA affairs such as vacancies and elections to the UNRWA Teachers Union. ¹²⁹ Every year UNRWA regional directors attend this summit and deliver remarks on behalf of the UNRWA Director General in Lebanon. In 2021, UNRWA Sidon Director Ibrahim Al-Khatib delivered remarks on behalf of Claudio Cardone as he has been doing for every Director General since at least 2018. ¹³⁰

At the 2021 conference, Hamas Lebanon representative Ahmad Abd Al-Hadi (discussed above under Cordone) also delivered a speech on the vision of the Palestinian Forces Alliance—an alliance of several terrorist groups including Hamas, PIJ, and Ansar Allah. He stated that he launched a joint committee to "supervise the relationship with UNRWA and ensure it implements its obligations." During the meeting, the PIJ representative in Lebanon Ihsan Ataya noted that "UNRWA is a living international witness to the refugee issue and must be preserved."¹³¹

Abu Attia Meets with PIJ on UNRWA Cooperation

Lebanon, January 2022

In January 2022, Abu Attia met with Palestinian Islamic Jihad leader Jihad Muhammad to reassert "the need for cooperation between local forces and UNRWA."139

Who is Jihad Muhammad?

Jihad Muhammad is the official in charge of UNRWA Relations in Lebanon for the PIJ. He is a key advocate for the right of return, which he explains means eliminating the State of Israel-"their [refugees] return to their homes from which they were forcibly displaced and ending the Zionist occupation of all Palestinian lands from the sea to the river."140 He also called on Lazzarini to resign for describing the October 7th atrocities as a "massacre."141

Kassab hosted two meetings at his office with the Palestine Liberation Front (PLF) (discussed above under Krähenbühl)-in January and November 2017.¹⁴⁹ At the November meeting which focused on UNRWA's liquidity crisis, Kassab was also joined by fellow UNRWA camp director Raef Ahmad. At that meeting, the PLF representative emphasized that donors must continue to fund UNRWA until the refugees "return to their homes." He pressed the UNRWA representatives to threaten the donors by stating that "any attempt to liquidate UNRWA is tantamount to declaring a systematic political war and punitive measures against refugees" and that this would lead to "popular revolution" by the Palestinians. 150
